## T121 MEMBERSHIP | TERMS & CONDITIONS (T&Cs)

• This agreement commences once you have indicated your acceptance in the T121 Membership Terms & Conditions section of the sign up process.

• The participant will be entitled to all the rights and privileges set for the type of membership Chosen.

• The participant understands that they are a T121 Member until cancellation notice is received via email or text message [admin@training121.com] [0868031944]

• The participant understands that Training121 have the right to cancel their membership if the participant is in breach of any of the terms and conditions given in this agreement and the overall terms and conditions cited in page 1.

• The participant understands that Training121 have the right to refuse access to classes for reasons including and not limited to: If the class selected is too advanced for the participant, etc. The participant understands that Training121 will recommend the best class options for the participant and it is the participants responsibility to contact the Training121 team via email or phone if they are unsure of which class or classes to book into with their session credits.

• The billing period is once every month for each month of the T121 membership. *EG:* If you start on Jan 3rd, your next bill is due is Feb 3rd.
